We provide them with a nurturing homely environment, and medical & psychological treatment. They usually are unable to perform their personal needs when we find them. At SNSWS they are treated as children of God, and are given the dignity that they deserve.

Registration

SNSWS is registered under the Societies Registration Act of XXI, 1860 vide Reg. No. S/60117/07. It is accorded with the status of a Charitable Organization by the Commissioner of Income Tax, under section 12A of the Income Tax Act 1961with tax exemption under 80 G.

Function

The society serves the needy and is administered by a governing body of prominent Social Workers and well-wishers.

Our Future Plans

Expand the existing House: Build one more floor to accommodate more needy people.

New Houses: We want to start more houses in Delhi and other states for the homeless.



Some highlights of the care...

- Provided with basic care like food, shelter, cloth and medicine.
- We facilitate rehabilitation and equip them to lead a normal life.
- The children who are terminally ill with minimal hope of recovery is given special care.
- We provide medical facilities to the best possible extend which is available in the city. Most undergo surgeries and long term treatment as they are brought in with infected wounds and worsened medical conditions.
- There are some who are aged and bedwridden and receives bedside care for basic needs too.
- Associated with other organizations and like-minded individuals for the guidance and expansion of the care.
- Death is unavoidable in the house and we take care to make their last moments peaceful. Having near and dear ones to comfort at the time of death is consoling and we make sure to give that in the best possible way.
- The last right is provided as per their faith.
- Almost all these children are on medications for problems like psychiatric, neuropathic, kidney diseases etc.
- We have Doctors, Nurses and othere healthcare workers offer voluntary service for the children.
- Many celebreate their important events like birthdays and anniversaries in the house.

Recreation

The children are provided with indoor games like carroms, puzzles, card games etc. Television facility is also provided. These activities help them to rejuvenate and re-energise leading to normal life.

Rehabilitation

Once the children become normal, many of them are able to remember their history and own family members and are able to provide their addresses. By using these addresses we are able to take them to their houses which are located in different parts of the country.

Those who are not able to find their family are allowed to be in the house and help the rest of the children in their day to day life.


